The Neshoba County Board of Supervisors is soliciting competitive, reverse auction bids from qualified vendors for the purchase of one (1) or more, new, 2021 Ford Police Interceptor Utility AWD vehicle(s); one (1) or more, new, 2021 Ford F-150 Crew Cab 4WD vehicle(s); and, one (1) or more, new, 2021 Ford F-350 Crew Cab 4WD vehicle. Neshoba County reserves the right to reject any and/or all bids and waive informalities. Neshoba County also reserves the right to accept the bid most advantageous to Neshoba County, Mississippi.
