# Deputy Commissioner Alex Henson October 29th, 1949 - April 2nd, 2020

Alexander Hamilton (Hamp) Henson was born October 29, 1949 in Noxapter, MS to the late Dewitt Henson and Laura Dell (Hathorn) Henson. At an early age he joined Mt, Pleasant #2 M.B. Church in Noxapater, MS where he was a faithful member and participant in young adult and adult programs until he moved to Neshoba County. Alex married Ms. Catherine Nichols in 1983 and moved to Philadelphia.

Alex graduated from Camille Hight Street High School in Louisville, MS in 1966. Attending Alcorn, A&M College in Lorman, MS graduating in 1970 with a B.S. in Agriculture. His career consisted of teaching school and coaching football, working offshore, working for USDA in Louisiana and working for Eastman Kodak in Rochester, New York. Later Mr. Henson started his own business as a poultry farmer 1996 and in recent years as a bus driver for the Philadelphia Public School System.

# **Coronavirus Food Assistance Program**

Are you a farmer or rancher whose operation has been directly impacted by the coronavirus pandemic? The Coronavirus Food Assistance Program will provide direct relief to producers who faced price declines and additional marketing costs due to COVID-19.

## About the Coronavirus Food Assistance Program

USDA Secretary Sonny Perdue announced the Coronavirus Food Assistance program on April 17, 2020. CFAP will use funding and authorities provided in the Coronavirus Aid, Relief, and Economic Security Act, the Families First Coronavirus Response Act, and other USDA existing authorities. This \$19 billion immediate relief program includes direct support to agricultural producers as well as the Farmers to Families Food Box Program.

CFAP will provide vital financial assistance to producers of agricultural commodities who have suffered a five-percent-or-greater price decline or who had losses due to market supply chain disruptions due

to COVID-19 and face additional significant market costs. Eligible commodities include:

- Non-specialty Crops: malting barley, canola, corn, upland cotton, millet, oats, soybeans, sorghum, sunflowers, durum wheat, and hard red spring wheat
- Wool
- Livestock: cattle, hogs, and sheep (lambs and yearlings only)
- Dairy
- Specialty Crops

Fruits: apples, avocados, blueberries, cantaloupe, grapefruit, kiwifruit, lemons, oranges, papaya, peaches, pears, raspberries, strawberries, tangerines, tomatoes, watermelons

**Vegetables:** artichokes, asparagus, broccoli, cabbage, carrots, cauliflower, celery, sweet corn, cucumbers, eggplant, garlic, iceberg lettuce, romaine lettuce, dry onions, green onions, peppers, potatoes, rhubarb, spinach, squash, sweet potatoes, taro

Nuts: almonds, pecans, walnuts

Other: beans, mushrooms

USDA will consider additional crops to be eligible for CFAP by collecting information on potentially eligible crops, as outlined under "Request for Additional Commodities" below on this page.

Eligible farmers and ranchers will receive one CFAP payment, drawn from two possible funding sources. The first source of funding is \$9.5 billion in appropriated funding provided in the CARES Act and compensates farmers for losses due to price declines that occurred between mid-January 2020, and mid-April 2020 and for specialty crops for product that was shipped and spoiled or unpaid product. The second funding source uses the Commodity Credit Corporation Charter Act to compensate producers for \$6.5 billion in losses due to ongoing market disruptions.

Beginning May 26, USDA's Farm Service Agency will be accepting applications from agricultural producers who have suffered losses. While offices are open by phone appointment only, FSA will be working with our

agricultural producers by phone and using email and online tools to process applications.

#### WHAT IS A SOIL & WATER **CONSERVATION DISTRICT?**

The Neshoba County Soil & Water Conservation District is a governmental subdivision of the State of Mississippi located in the Third Congressional District. The formation of the Conservation District was authorized by the MS legislature on April 4, 1938, through House Bill 454. The Neshoba County SWCD was organized by citizens of Neshoba County on October 30, 1939.

The Neshoba County SWCD is governed by five commissioners. Three are elected in a district (county) wide election by landowners. Two are appointed by the MS Soil & Water Conservation Commission upon recommendations of the SWCD board of commissioners. Each District is authorized to appoint five deputy commissioners. These commissioners serve without pay to carry out a cooperative program that addresses the natural resource concerns of the District.
